'Bama's immigration law has unintended consequences

Like so many laws, Alabama's new "Public Safety and Homeland Security Act" has noble intentions, but is already creating a plethora of unintended consequences.

The Act is aimed at more easily finding and deporting illegal aliens. It does this by allowing police officers during traffic stops to inquire about the citizenship of those whom they have a "reasonable suspicion" may not be here legally. If the person cannot produce proof of citizenship, then they can be detained immediately for deportation proceedings.

But here's the problem (among many): This law gives an enormous amount of discretion to Alabama's police officers that can readily be abused. First, there will be many U.S. citizens who may not have a driver's license on them or other government document when pulled over. What otherwise may have been a ticket now might turn into an immediate arrest primarily (or even only) because of how one looks.

And this raises the specter of racial and ethnic profiling. What does an illegal alien look like, after all? Do they have darker skin like Hispanics or southern Italians? Lighter skin like Canadians or Germans? What will police officers base their reasonable suspicion on? An accent? Clothing? For that matter what does a U.S. citizen

look like? A moment's reflection and one begins to see the problem with enforcing this law, and the innumerable law suits that will be brought by, say, a family from Ohio visiting relatives in Alabama that may be travelling without birth certificates, passports and accidentally left their wallet at grandma's.

Additionally, many illegal aliens have had children while residing in the United States. These children are U.S. citizens, period. Unfortunately, at least in Alabama, these children, now supported by their parents, will soon be wards of the state (of Alabama). Their parents, after all, will be deported. Are we to deport their U.,S.-citizen children with them?

No doubt and for good reason we have state and federal laws that make it illegal for foreign nationals to illegally reside and work in the United States. But sometimes how we choose to enforce such laws can turn out to cause far more harm than good.
